Membership Privileges • BASIC

Adult, Couple (married couple), Teen, Youth and Senior (age 62 and older) BASIC membership includes unlimited access to cardio/weights and open gym times according to your payment schedule. Occasionally there will be times when the gym is not available, see the front desk for an open gym schedule.

Membership Privileges • PLUS

Adult, Couple (married couple), Teen and Senior (age 62 and older) PLUS membership includes unlimited access to cardio/weights, open gym times, core fitness classes (as defined on core fitness class schedule), indoor playground and discounts on select youth programs according to your payment schedule. Annual PLUS members will receive discounts on selected youth and adult programs. Occasionally there will be times when the gym and/or classes are not available, see the front desk for current open gym/class schedule.

Facilities and Equipment

Equipment orientations will be provided to new members by scheduled appointment. BCRD FitWorks reserves the right to determine facility hours and services provided. It is understood that equipment may be unavailable to do cleaning and/or service.

Membership Card

You must present your membership card at the front desk when entering the facility and cards are nontransferable. Abuse of a membership card may result in termination of the membership. Replacement cards can be purchased for \$3 in the case that they are lost or stolen.

Refunds or Stop Payments

No refunds will be given on one-month memberships or day passes. Any checks returned by the bank will be charged an additional \$20.00 fee. The original amount and the \$20.00 additional fee must be paid before any additional privileges will be granted. If this occurs again with one year, all future payments will be required to be made in cash or by credit card.

Termination of Annual Membership

Termination of an annual membership may be done without an early termination fee if: 1) an injury or illness renders you unable to use the facility or 2) you move more than 50 miles away from the facility. If you choose to voluntarily terminate an annual membership, you are obligated to pay an early termination fee that is equal to half of the remaining months left on your membership.

BCRD FitWorks reserves the right to terminate due to non-payment of membership fees, or failure to comply with the Guidelines as set forth by BCRD FitWorks. If membership is terminated for non-payment, the remaining balance must be paid in full prior to future renewal of membership.

Agreement and Release of Liability

I do hereby waive, release and forever discharge BCRD FitWorks, its officers, and employees from any and all responsibilities or liability for injuries or damages resulting from my participation in any activities or use of equipment in the above mentioned facility.

I understand and am aware that strength, flexibility and aerobic exercise, including the use of equipment are potentially hazardous activities. I also understand that fitness activities involve a risk of injury or illness and that I am voluntarily participating in these activities and using equipment with knowledge of the dangers involved. I hereby agree to expressly assume and accept any and all risks of injury or illness.

I acknowledge that I have either had a physical examination and have been given my physician's permission to participate, or that I have decided to participate in the activities or use of equipment at BCRD FitWorks.
